

Utah School District School Board Highlights

February 9, 2010 business meeting

Superintendent's Report:

Superintendent Mark Dockins shared the most current data information on YPP, winter DIBELS, and NWEA.

Approval of Utah Consolidated Application (UCA): A motion was made by Allen Huber to approve the UCA plan for 2009-2010. Teera Young seconded the motion; motion carried.

Proposal for Winter Sports Facility/Maintenance Building: A motion was made by JoAnn Cowan, seconded by Teera Young, carrying unanimously, to convert the old swimming pool building into a winter sports facility. Bids shall include the three following options:

Option A: Fill in the swimming pool, fix the roof, windows, plumbing, heating, plan for netting for multi-sports, and cover with turf;

Option B: Same as Option A, plus remove select interior walls to increase available practice area;

Option C: Same as Options A and B, except instead of filling in pool, remodel it into a basement area for batting cages.

It is also directed that the remaining "blue buildings" by the Vernal Jr. High will be converted into a warehouse for the Maintenance Department.

Utah High School administration is directed to develop a list priority of upgrades for the sporting facilities areas at the school.

Lapoint Elementary Review: Principal Dennis Atkin gave a quarterly progress report on plan implementation for Lapoint Elementary.

Approval of Changes to Substitute Custodian Salary Schedule: A motion was made by Allen Huber to approve the request to raise the wage for substitute custodians from \$7.00 per hour to \$7.50 per hour. Teera Young seconded the motion; motion carried.

Approval of Policy 005.0310 Reduction in Force: (1st & 2nd Reading) A motion was made by Allen Huber to approve Policy 005.0310 as presented. Teera Young seconded the motion; motion carried.
